Alternatively, you might introduce the interviewee within the sentence:

According to Jane Smith, oral traditions play a crucial role in preserving cultural identity (personal interview, 12 March 2023).

This method keeps your writing clear and acknowledges the source of the information without needing a Works Cited entry.

In-Text Citation for Published Interviews

If you are referencing a published interview, such as one found in a book, magazine, or online article, you treat it like any other source with an author or editor.

- Include the last name of the interviewee or the interviewer, depending on who is more relevant to your point.
- If the interview is part of a larger work, include page numbers if available.

Example:

In the interview, John Doe discusses the challenges faced by contemporary artists (Doe 45).

If the interview is accessed online without page numbers, simply use the author's last name:

According to the interview with John Doe, contemporary artists face numerous obstacles (Doe).

Make sure to include a full citation in your Works Cited list for the source where the interview appears.

Citing Broadcast Interviews In Text

Broadcast interviews, such as those from TV or radio, are cited slightly differently.

- Mention the interviewee's name and, if relevant, the timestamp of the segment quoted.
- If you're citing a specific part of a broadcast, including the timestamp helps readers locate the quote.

Example:

As noted by Dr. Jane Lee in the interview, the medical advances are groundbreaking (Lee 00:15:32-00:16:05).

This citation is useful when you want to pinpoint a specific moment in a longer broadcast.

Tips for Writing Natural and Clear In-Text Citations for Interviews

When incorporating interviews into your writing, clarity is key. Here are some practical tips to keep your citations professional and reader-friendly:
